The judiciary and legal bar make up about 20%, consisting of judges and legal counsels who bring practical experience to the discussions. Additionally, 20% of our audience comes from NGOs and civil society organizations, represented by executives and program directors who advocate for community-based solutions. Finally, 15% of our delegates represent the private sector and technology, including LegalTech founders and compliance officers, who provide a critical perspective on the intersection of law and technology.
